 - a) Being interviewed at the event, and
 - b) Wearing a portable microphone during the competition.
- I am aware that there are risks, dangers and hazards inherent to the sport of curling and in my preparation for, travel to and from, and participation in any curling related activity which is organized, operated and sanctioned by CurlManitoba.
 - The risk, danger and hazards include, but are not limited to: injuries from vigorous exertion and strenuous cardiovascular workouts, injuries resulting from slips or falls to the ground, injuries from being struck or colliding with other participants, risks associated with travel to and from the competition location, and additional risks associated with non-competitive activities which are an integral part of the competitive event
 - I also understand that injuries sustained in curling or competition can be severe and even fatal, I agree to participate in the sport of curling and acknowledge the associated risks involved in my participation and willingly assume those risks.
