1. I acknowledge that I have reviewed and will comply with the Rules of the "Hit, Draw, Tap Competition" as posted on [www.curlmanitoba.org](http://www.curlmanitoba.org).
2. I hereby agree to comply with all provisions of the Rules of the competition, in particular but without limiting my agreement to comply with all the, I agree as follows:
  - a) I understand that the Curling Code of Ethics set out at the beginning of the CurlManitoba rulebook is an intrinsic part of the sport of curling and of this event in particular, and I agree to abide by that code.
3. I agree to comply with all the rules and regulations respecting advertising, and dress code as established by CurlManitoba and its sponsors and communicated to me through the Rules.
4. I consent to CurlManitoba and their agent or appointees:
  - a) Photographing
  - b) Video Taping
  - c) Filming and/or
  - d) Recording my voice; and further
  - e) Exhibiting, publishing and broadcasting my name and any photographs, video tapes, films or any other likenesses of me or any sound recording of my voice in any promotion, reports or advertising about or in connection with CurlManitoba or the event.
5. I hereby waive the right to any payments or royalties in connection with the actions described in subparagraph 4 a), b), c) and d) above in the connection with any exhibition, publication or broadcast described un subparagraph 4 e) above regardless of whether such exhibition, publication or broadcast is on a commercial basis and regardless of whether a fee or rental is charged or paid to anyone in connection with such exhibition, publication or broadcast.
6. For the purpose of promoting the sport of curling any telecast relating to the event, I consent to:
  - a) Being interviewed at the event, and
  - b) Wearing a portable microphone during the competition.
7. I am aware that there are risks, dangers and hazards inherent to the sport of curling and in my preparation for, travel to and from, and participation in any curling related activity which is organized, operated and sanctioned by CurlManitoba. The risk, danger and hazards include, but are not limited to: injuries from vigorous exertion and strenuous cardiovascular workouts, injuries resulting from slips or falls to the ground, injuries from being struck or colliding with other participants, risks associated with travel to and from the competition location, and additional risks associated with non-competitive activities which are an integral part of the competitive event.  
I also understand that injuries sustained in curling or competition can be severe and even fatal, I agree to participate in the sport of curling and acknowledge the associated risks involved in my participation and willingly assume those risks.
8. I have been given the opportunity to obtain independent legal advice prior to signing this agreement and fully understand its provisions. No person has attempted to unduly influence my signing of this agreement. I have signed this agreement on my own after careful consideration of all the provisions.
